Background

- 8. Since the last Full Council meeting (13 February 2024) all feedback has been collated. Thank you to all staff and councillors who have provided feedback. The feedback has been reassuringly positive.
- 9. Only minor changes have been made to the draft committee structure and responsibilities.
- 10. The council needs to approve the committee names. The names present in Appendix A are just one option, but there were mixed comments as to the names Corporate Governance (some feeling that this should be kept as P&R) and alternative names suggested for the new 'Environment and Assets Committee'. All committee names can be

- changed / left as is but the council does need to decide this to enable work to continue. New committee names will give the committees a fresh restart / rebrand.
- 11. Some minor changes to the timeline have been made to timeline, which should be noted, however the work is still on track for a new committee structure and membership in place for the Annual Meeting (14 May 2024).
