

**OXFORDSHIRE COUNTY COUNCIL  
(THAME AND VARIOUS PARISHES) (SPEED LIMITS) ORDER 20\*\***

The Oxfordshire County Council in exercise of its powers under Sections 82, 83 & 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Thame and Various Parishes) (Speed Limits) Order 202\* and shall come into force on the            day of            202\*, and variously includes the Parishes of Great Haseley, Great Haseley, Great Milton, Lewknor, Moreton, Post combe, Thame, Tiddington with Albury, Towersey and Tetsworth.
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour in any of the lengths of road specified in Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour in any of the lengths of road specified in Schedule 2 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour in any of the lengths of road specified in Schedule 3 to this Order.
5. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour in any of the lengths of road specified in Schedule 4 to this Order.
6. No speed limit imposed by this Order applies to a vehicle falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, being a vehicle used for naval, military or air force purposes, when used in accordance with regulation 3(5) of those regulations.
7. The Oxfordshire County Council (Thame and Various Parishes) (Speed Limits) (No.2) Order 2023 is hereby revoked.

**SCHEDULE 1**

20mph speed limit:

**Thame**

The whole length of every road in Thame (excluding any lengths of road specified in schedules 2, 3 or 4) extending in the case of the respective roads leading out of the town to the following points:

a)	B4445 Aylesbury Road	to a point 59 metres south of its roundabout junction with the A418, B4011 & A4129
b)	B4445 Chinnor Road/Garden City	its roundabout junction with the B4012 & the B4445 Chinnor Road
c)	Cheshire Road	its junction with the B4012 Howland Road
d)	Cromwell Avenue	its junction with the A4129 Tythrop Way
e)	Fanshawe Road	its junction with the B4012
f)	Jane Morbey Road	its junction with Thame Park Road
g)	Kingsey Road	to a point 50m southwest of its roundabout junction with the A4129 & the B4012
h)	Massey Road	its junction with Thame Park Road
i)	Oxford Road	a point 35 metres east of its roundabout junction with the A329 & A418
j)	Pearce Way	its junction with the B4012 Howland Road
k)	Pickenfield	its junction with the B4012 Howland Road
l)	Queens Close	its junction with the B4445 Aylesbury Road
m)	Roundhead Drive	its junction with the A4129 Tythrop Way
n)	Thame Park Road	a point 15 metres south of its junction with Chowns Close
o)	Vane Road	its junction with the A4129 Tythrop Way

## Towersey

The whole length of every road (excluding any length of road specified in schedules 2, 3 or 4) in the village of Towersey extending (in the case of the respective roads leading out of the village) to the following points:

a)	Chinnor Road	a point 555 metres southwest of its junction with Thame Road / Manor Road
b)	Manor Road	a point 445 metres southeast of its junction with Chinnor Road / Church Lane

c)	Thame Road	a point 145 metres northwest of its junction with Windmill Road
d)	Windmill Road	a point 367 metres north of its junction with Thame Road

## SCHEDULE 2

30mph speed limit:

### **Thame**

The whole length of every road in Thame, extending (in the case of the respective roads leading out of the town) to the following points:

a)	Aylesbury Road B4445	to a point 59 metres south of its roundabout junction with the A418, B4011 and A4129
b)	Cheshire Road	to its junctions with the B4012 Thame eastern perimeter road
c)	Chinnor Road B4445	to a point 75 metres south east of its roundabout junction with B4012
d)	Cromwell Avenue	to its junctions with the A4129 Thame northeast perimeter road
e)	Fanshawe Road	to its junctions with the B4012 Thame eastern perimeter road
f)	Howland Road B4012	to a point 42 metres northeast of its roundabout junction with the B4445-Chinnor Road
g)	Kingsey Road	to a point 50m southwest of its roundabout junction with the A4129 and B4012
h)	Oxford Road	to a point 35 metres east of its roundabout junction with the A329 and A418
i)	Pearce Way	to its junctions with the B4012 Thame eastern perimeter road
j)	Pickenfield	to its junctions with the B4012 Thame eastern perimeter road
k)	Roundhead Drive	to its junctions with the A4129 Thame northeast perimeter road

l)	Thame Park Road, B4012	to a point 215 metres south of its junction with Wenman Road
m)	Vane Road	to its junctions with the A4129 Thame northeast perimeter road

a)	B4012 Howland Road	from its roundabout junction with the B4445 Chinnor Road, north-eastwards	for a distance of 42 metres.
b)	B4012 Wenman Road	from its junction with Thame Park Road, eastwards	to its roundabout junction with the B4445 Chinnor Road & B4012 Howland Road
c)	B4445 Chinnor Road	from its roundabout junction with the B4012 Howland Road, south-eastwards	for a distance of 75 metres.
d)	Dormer Road	from its junction with the B4012 Wenman Road, northwards	to its junction with the B4445 Chinnor Road/Garden City
e)	Lupton Road	from its junction with the B4012 Wenman Road, northwards	for its entire length
f)	Station Yard	from its junction with Thame Park Road, eastwards	for its entire length
g)	Thame Park Road	from a point 15 metres south of its junction with Chowns Close, southwards	to a point 215 metres south of its junction with Wenman Road

## Moreton

a)	Judds Lane	From a point 200 metres south of its junction with the unnamed road (running south-westwards) to Elmfield House, north-east and south-eastwards for a distance of 775 metres
b)	Road from the A329 to Moreton	From its junction with Judds Lane north-westwards for a distance of 75 metres
c)	Un-named road to Elmfield House	South-westwards for its entire length

d)	Un-named road	From its junction with Judds Lane to its junction with Thame Road
e)	Un-named road	From its junction with Judds Lane, north-eastwards for its entire length.

### Towersey

a)	Thame Road	from a point 145 metres northwest of its junction with Windmill Road, north-westwards	for a distance of 330 metres.

a)	A329 Rycote Lane	from a point 44 metres southwest of its junction with the A418, south-westwards	to a point 425 metres west of its junction with Moreton Road (partly in the Parish of Great Haseley).
b)	A4129 Kingsey Road	<del>between a point 22 metres southeast of its roundabout junction with the A418 Aylesbury Road and</del> from its roundabout junction with the A4129 Tythrop Way / B4012 Howland Road, north-eastwards	<del>a point 80 metres east of its roundabout junction with the B4012.</del> for a distance of 80 metres.
c)	B4012 Howland Road	from its roundabout junction with the A4129 Tythrop Way / Kingsey Road, southwards	to a point 42 metres northeast of its roundabout junction with B4445 Chinnor Road.
d)	Kingsey Road (west)	from its roundabout junction with the A4129 Tythrop Way / B4012 Howland Road, westwards	for 50 metres.

e)	Towersey Road	from its junction with B4012 eastwards	for 47 metres.

a)	B4012 (beginning as Thame Park Road)	from a point 215 metres south of its junction with Wenman Road, Thame, southwards	to a point 35 metres north of its junction with the A40, Postcombe.

2). **A418** from Thame towards Wheatley – within the Parishes of Thame, Tiddington with Albury and Great Milton and Great Haseley:

b)	A418 (Thame to Tiddington)	From its junction with the A329, Thame, westwards	to a point 250 metres east of Ickford Road, Tiddington.
c)	A418 (Tiddington towards Wheatley)	From a point 340 metres west of its junction with Sandy Lane, Tiddington, westwards	To its junction with the A40, Great Milton.

3). **A329** Milton Common to Thame – within the Parishes of Thame, Great Haseley and Tetsworth.

d)	A329 (Milton Common to Thame)	from a point 118m northeast of the A40 London Road, north-eastwards	to a point 425 metres west of its junction with Moreton Road, Thame.
