1. Purpose of the Report

1.1 To update the Committee on action taken against Thame's Green Living Plan since last report to Environment & Assets Committee on 3 September 2024 and the plans for the next quarter.

1.2 To present a motion for Thame to work towards achieving 'Plastic Free Community' status.

2. Green Living Plan Working Group (GLPWG)

- 2.1. Following the last committee meeting there have been two meetings of the GLPWG, in October 2024 and January 2025.
- 2.2. At each of these meetings, 7 actions that the Environmental Project Officer (EPO) deems to be completed were presented for ratification by the working group.
- 2.3. Prior to the meetings the EPO investigated each action to be presented, talking to relevant partners involved, creating a public-facing webpage to show details of how the action had been achieved and confirming with Thame Green Living (authors of the plan) that they were in agreement that the actions have been completed. This same approach will also be taken with all future actions
- 2.4. GLPWG members are asked to identify the actions as one of the following:
 - Fully completed,
 - Complete, but needing to be repeated (either on a regular basis, or in future editions of the plan),
 - Needing further action and therefore not yet completed.

5. Focus for this year

- 5.1. There are several different focus areas that will develop over 2025, all helping to support the achievement of actions, either fully completing them, contributing towards completion or ensuring that they are incorporated into other plans that will ensure their completion once funding becomes available in the future. These are outlined here.
- 5.2. **TNP2** (referendum February 6th): potentially 12 actions. If residents of Thame vote 'Yes' at the upcoming referendum then elements of the GLP will then be incorporated into the Thame Neighbourhood Plan.
- 5.3. **Air Quality Project** (launching February 2025): 7 actions. Project with a focus on schools, but some action across the town too. This will run for 2 3 years.
- 5.4. **Thame Business Sustainability Award** (Possible launch March): 25 actions. Currently in a pilot phase. A plan for local businesses identifying the action they can take to support the achievement of the GLP, as well as further actions to progress on their own sustainability journey. If successful, the ambition will be to link the results into a new Town Award and launch to the wider community in March.
- 5.5. The Local Cycling & Walking Infrastructure Plan (LCWIP) (expecting completion by April 2025): 23 actions. This is being led on by OCC and should be completed with the first quarter of this year. We are actively engaged with the progress, and part of the Steering Committee, seeking to shape it to local feedback and local need.
- 5.6. **Plastic Free Communities** (aiming to launch in first quarter of this year): 2 actions. This initiative gained a lot of support from the community in 2020, but due to the capacity of the volunteers involved became quieter. It has been re-energised by local business ASM who are seeking 'Plastic Free' status and are willing to devote staff time to support the initiative across the local community. In order for Thame to gain 'Plastic Free Town' status, the Town Council needs to support the following motion.

Thame Town council will:

- 1. Lead by example and remove single-use plastic items from their premises.
- 2. Encourage plastic-free initiatives, promoting the campaign and supporting events.
- 3. Put a named representative of the council on the Plastic Free Community steering group.
